Sir,

The Medical Assessment and Rating Board has received online application (Part-1) seeking permission for student intake in (Under Graduate (BHMS) course with intake capacity of 63 seats including 13 EWS seats for the academic year 2022-23.

2. As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that Part-1 proforma and all the relevant documents submitted by your college were examined as per the existing regulations.

3. On careful examination of the report, the Medical Assessment and Rating Board has observed the following shortfalls-

**A. HOSPITAL STAFF**

a. Medical Officer 01 available against 02

b. Surgeon (General Surgery), Obstetrician/Gynecologist, Pathologist/Biochemist, House Physician (Resident), Laboratory Technician, Nursing staff Incharge, Nursing staff, Registration Clerk/Telephone Operator, Dietician (Part time), Physiotherapist, Hospital reception staff, Anesthetist, Radiologist, X Ray Technician/Radiographer, Lab attendant, Auxiliary-Dark room attendant, and Auxiliary staff are not available.

**B. MEDICAL COLLEGE**

College is directed to submit department wise teaching faculties engaged in UG and PG course.

After considering the provisions of NCH Act, 2020 and its relevant regulations, permission of the Medical Assessment and Rating Board is granted to Pt. Jawahar Lal Nehru State Homoeopathic Medical College and Hospital, Block A/1, Scheme-38, Lakhanpur, Kalyanpur, Kanpur- 208024 Uttar Pradesh for 125 seats in Under Graduate course (BHMS) and 15 seats for PG (MD) courses including 03 seats for EWS Quota (Homoeopathic Materia Medica 08 seats, and Repertory 07 seats) for the academic year 2022-23.

4. All deficiencies observed by Medical Assessment and Rating Board shall be rectified and the compliance report may be submitted within a period of one month and an affidavit in this regard may be submitted within a period of 07 days.
5. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules. It is further informed that, minimum 15% seats of permitted intake capacity of BHMS course shall be treated as All India Quota and the penalty as decided will be imposed on any such practices.
6. The counselling for seats under All India quota shall be conducted by respective counselling Authority of State/ UT Government as designated by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counselling of seats under All India Quota shall be conducted by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
7. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
